



## **4-H/FFA Market Rabbit Show 4-H / FFA Breeding Rabbit Show**

The 4-H/FFA Market Rabbit Show will be held on Monday, July 27th at 6:30 P.M. in the small arena or rabbit barn. The 4-H/FFA Breeding Rabbit Show will be held on Saturday, August 1st starting at 9:00 A.M in the small arena. Entry forms have been included-they are due at the Extension Office on June 1, 2020.

### **Ethics and Quality Assurance Training**

Ethics and quality assurance training is required by all 4-H animal project members. If members do not complete this training by July 1, 2020, they will not be able to show.

### **Project Books**

Project books will be due on Saturday, July 18 by 2:00 P.M. at the 4-H Building in Troy. You will need to complete all requirements for the breeding/pet or market rabbit project. Cavy for cavy members. All completed projects are due at the Fairgrounds on Saturday, July 18 by 2:00 P.M. or at the Extension Office by 12:00 P.M. on Friday, July 17th.

### **Project Book Guidelines (complete each requirement)**

- 1. Complete Breeding or market record book**
- 2. Project Poster and Oral Presentation to the club.**

If your books are not turned in on time and receive at least a white ribbon you will not be eligible to show your project at 4-H Roundup.

If you want to know how your project books will be judged, scoresheets are available in the Extension Office.

## **Arrival at the Fair**

### **Bunny Barn:**

Rabbits will be on display and cared for by barn manager all week at the fair, please indicate the number of cages you require. Drop off time Sunday 3-8pm or Monday 8:00 am- 1:00pm. Contact person is Linda Elsbree, 570-905-0923. Volunteers for watching Rabbit barn are needed, please indicate days and times available on entry forms. Passes will be provided.

### **Breeding Rabbits:**

Cloverbuds and those breeding rabbits who we may not have room for may come day of Breeding Show between 8:00- 9:00 a.m. on Saturday, August 1st. All rabbits will need to stay until 5:00 p.m. on Saturday, August 1, 2020.

### **Market Rabbits:**

Meat rabbit pens can arrive Monday July 27th no later than 6:00 P.M. in the Small Arena. Pens of meat rabbits will sell during the 4-H/FFA Livestock Sale on Wednesday, July 29th.

**It is the responsibility of the exhibitor to clean all their cages before leaving the fairgrounds. Any Exhibitor who does not clean out their cage(s) will be charged a \$20 fee or risk forfeiting their right to show in following years.**

### **Health Requirements for all rabbits:**

All rabbit exhibitors need to fill out and sign an Animal Owner or Caretaker's Verification of Veterinarian-Client-Patient Relationship form. This form will need to be presented upon arrival at the Fairgrounds. [It is on bottom of your Entry form! Sign it!!](#)

### **Section 15: Pennsylvania Rabbits**

#### **Requirements:**

1. All animals must be free of evidence of infectious and contagious diseases.

### **Section 16: Out of State Rabbits**

#### **Requirements:**

2. A Certificate of Veterinary Inspection (CVI) issued within 30 days prior to the date of importation.
3. A statement on the CVI attesting that all rabbits listed on the CVI are free of signs of infectious and contagious disease

## Breeding Rabbit Show

\*\*Show begins at 9:00am on Saturday August 1<sup>st</sup>, in the small arena.

Show Rules.

1. **All rabbits must be owned by the exhibitor by May 15, 2020. All entries are due at the Extension Office by June 1, 2020.**
2. All carriers must have a leak-proof bottom.
3. All rabbits must have a permanent mark in the left ear. Excluding clover buds and cavies.
4. All 4-H/FFA rabbit exhibitors must wear a long sleeve shirt or a show jacket. There will be no open toed shoes allowed.

- Cloverbuds are welcome to bring rabbits for a special Cloverbud class, dress up contest and showmanship class. No tattoo required of Cloverbud rabbits. Day of show only!
- Any Cloverbuds who want to participate, please fill out an entry form with the name of the rabbit you will be using. (not required to use this rabbit if circumstances change)
- There will be no placing of Cloverbuds.

**Market Rabbit Show**

\*\*Market Meat Rabbit Show for meat rabbit pens will be held on Monday, July 27th at 6:30 P.M. in the small arena.

For meat rabbit exhibitors

1. Bring meat pens in trios.
2. The sexes of your 3 meat rabbits can be mixed.
3. Meat rabbits will be weighed in at 6pm before the market show.
4. 2 Meat Pens may be shown per exhibitor but only 1 may be sold unless receiving both Grand and Reserve Champion honors
